<u>I have a certificated holding in Majedie Investments PLC, how can I deposit</u> these into my Equiniti Investment Account?

To deposit certificates with Equiniti you will need to complete and sign a CREST transfer form for each holding. If you hold multiple certificates of the same company, only one CREST transfer form is required. You will then be required to send us the CREST transfer form along with the certificate(s) and we will then arrange for these to be deposited into your account.

If the certificates are worth a significant amount, you may wish to consider sending the certificate(s) via registered post.
